












Internal Quality Controlling



Fabrics and Trim checking and testing:

- The quality of fabrics are major issue for garments production. At MAYHAI, all bulk fabrics are inspected by Cloth
- Inspection Machine with the rating 10%. A checking system for bulk fabrics is used by MAYHAI as called "AQL Four Point System". In case that the defect rating is higher than allowed tolerance, we will implement fully checking 100% of bulk fabrics. Before starting bulk production, we implement the Fabrics Testing program a minimum 1 yardage will be taken for shrinkage testing at ironing, stitching and washing. A small piece good is taken from each roll of fabrics for color shade lot testing. The checking of Trims/Accessories quantity/quality is performed in 15% inspection.

Pre-production meeting

Frequently, we perform the pre-production meeting between Technical department, Line supervisor, In-line QC and Technical chief of sewing workshop prior to bulk production to go through the garment in order to identify any technical difficulties that may occur, and to ensure that all quality requirements from customers will be applied.

Cut-pieces Inspection:

Cut pieces are 100% inspected before passing to sewing process. Our QC will perform the checking cut pieces against marker/pattern, layer height, width/length spreading.

Internal Quality Controlling (con't)

In-Line inspection:

In-line inspection is performed by the In-line QC. They will inspect 100% and return the defected piece to the operator for repairing. These inspection include checking measurements. In-line QC will report all updated issue concerning quality to Line Supervisor for everyday. Moreover, the In-line Qc will assist the operator in starting new style

End-line inspection:

is performed by a separated QC team, they will implement 100% inspection on finished garments. Any defected finished garment will be returned to Sewing line for resewing. They will make the daily report on quality issue to sewing workshop manager.

Pressing & Packing inspection:

All garments after ironing & Packing are inspected thoroughly by QC at Packing section. The QC check the hangtag position, carton stickers, and select carton box for random checking.

Final inspection:

- Final inspection is based on the rating system AQL 2.50 or AQL 1.0 at Buyer's requirement. The final inspection is carried out separately by QA Department after 80% of completed and packed at least. Based on AQL 2.5 or AQL 1.0,
- QA auditor will select sampling for checking. Details of order, measurement and workmanship of garment, color matching, packing, carton box appearance are fully checked by QA auditor. By constant renovation of equipment, application of advanced technology and know-how, and continuous improvement of quality system, we are satisfying our customer's demand and expectation. It is committed that our employees are properly qualified to fulfill their assigned tasks. We undertake that all processes in our quality policy and quality control have been popularized to all employees who are to comply with the guideline, procedures and processes in the quality system ISO 9001.
